CODE OF CONDUCT FOR COACHES

A coach is expected to accept and understand the seriousness of his/her responsibility and the privilege of representing the Lee County Recreation Department and your community.

A coach is expected to gain an understanding of and an appreciation for the rules of the game. A coach should remember that the rules of the game are designed to protect the participants, as well as to set a standard for competition.

A coach is expected to exhibit respect for the officials at all times and to treat them with respect, even if they disagree with their judgement. A coach is expected to refrain from arguments in front of players and spectators, making gestures which indicate an official or opposing coach does not know what he or she is doing or talking about, or throwing objects in disgust.

Remember – recreational athletics are learning experiences for participants and mistakes will be made. Praise athletes in their attempts to improve themselves both as young athletes and as people.

Youth sports are for the children - adults are there to facilitate play while displaying good sportsmanship.

A coach should remember the safety and welfare of the children can never be compromised.

A coach should care more about the players as people than as athletes.

A coach should be the first person to demonstrate good sportsmanship. He or she should take a low profile during the game and allow the kids to be the center of attention.

A coach has an important role in molding the athletic experience of the child. Parents and players place their trust and confidence in their coach. Children who mature socially and physically while participating in sports are the best indication of good coaching.

It is your leadership as a coach that children will remember long after the games are forgotten.

PENALTIES FOR UNACCEPTABLE BEHAVIOR

Any parent, coach or spectator acting in an unsportsmanlike manner or in any way that could prove detrimental to any player, official, coach or another spectator will be subject to disciplinary action by the Lee County Recreation Department.

1. Language unbecoming to the league event - Suspension: 1 game.
2. Unsportsmanlike conduct/ejection from game/program - Suspension: Current game + 1 game.
3. Touching, striking or approaching a coach/official/Recreation staff in a threatening manner - Suspension: indefinite.
4. Damage to recreation property - Suspension: indefinite.

I understand that I may be removed from my coaching position should I display any behavior (past or present) that could be deemed detrimental to the league including postings on social media, emails and/or text message.
